DIRECTIONS TO SHOW SITE

The trial will be held outdoors on grass at Boonsboro Ruritan Club

Lower Field 1499 Coffee Road, Lynchburg, Virginia 24503

Alternate address for GPS: 1065 Bradley L Gaertner Place, Lynchburg, VA 24503

In general, follow the signs to Rt. 501 North. Here are the details:

US 460 - From the West of Lynchburg: From 460, take the right-hand exit to 460 E Business (Timberlake Rd). Proceed for about 3 miles to Route 501. Exit onto 501 North and go about 2 miles to a traffic light at Rt. 221

Continue straight on Rt. 501 N through the light at Rt. 221. At the next light, turn left

to stay on Rt. 501 North. At the next light at Boonsboro Rd., turn left (still 501 N) and go

about 2 miles. Turn left onto Coffee Road (Rt. 644) [Dollar General Store will be on the left] and go about 2 miles. The Boonsboro Ruritan Club Building is on the right.

US 460 - From the East of Lynchburg: Exit Rt. 460 at Candler's Mountain Rd (a right turn exit). Follow signs to Rt. 501 North (River Ridge Mall will be on your left, and La Quinta Inn will be on your right). Take the exit ramp to the right to Rt. 501 North. Follow 501 N for about 3 miles to Lakeside Dr./Rt.221 See italics above.

US 29 - From the North of Lynchburg: After passing the town of Amherst, stay on Route 29 South. (Do not take Business Rt. 29 South). This is the limited-access Madison Heights Bypass. After crossing the James River, Rt. 29 will join Rt. 460 West. DO NOT take Rt. 501 North Business at Campbell Ave. Continue to Candler's Mountain Rd and follow signs for Rt. 501 North. (River Ridge Mall is on the left, and La Quinta Inn on the right). Take the exit ramp to the right to Rt. 501 North. Follow 501 N for about 3 miles to Lakeside Dr./Rt.221.

US 29 - From the South of Lynchburg: Follow Business Rt. 29 North into the city limits (pass River Ridge mall entrance on your right). Take the exit ramp to the right to Rt. 501 North and proceed for about 3 miles to Rt. 221. See italics above.

EQUIPMENT and CREW

Lure Equipment: Speed Dog runs all their Fast CATs utilizing a continuous loop system. Speed Dog uses and endorses the SwiftPaws system for their record in safety and reliability. The lure or “bunny” consist of white plastic bags. Additionally, a squawker is sometimes used – if track conditions allow. The lure is attached to string that is set in a continuous loop and the string is pulled/pushed by an electric motor (SwiftPaws),

Timing Devices: Speed Dog uses and endorses Farm Tek electronic timing devices. At most events we have a redundancy system set up to help reduce timing issues and reruns.

Field Conditions. The field is fairly level. The surface is grass that is mowed short. The track is approximately 460’ long and is fully fenced with mesh fencing. Mounted entry and exit gates are also part of the track. Handlers may walk the course to the catch area **BEFORE** their dog is released.

Hunt Master Is not just someone standing at the Start line twirling their arm, they are an integral part of the overall safety of the dog and human. They are in complete charge of all hounds and handlers on the field. They are responsible for calling the next dog/handler onto the course. They are responsible for making sure the correct dog is on the start line. They are responsible for checking collars. The Huntmaster explains the release and, if necessary, the retrieval before the dog is released. They are responsible for making sure the lure is in position and traveling in the correct direction before calling the dog/handler onto the course. The handler should communicate to the Huntmaster any special needs the dog may have (Fast, slow, old, new). The Huntmaster will communicate any needs to the Lure Operator. The Huntmaster shall question the Lure Operator, Timer and handlers asking “Are you ready?” After affirmative answers from all parties, the Huntmaster will begin the course. Provides a hand signal to the Lure Operator to start the lure. Gives the verbal signal “Tallyho” to release the dog from a standing start. The dog should not be slipped before the sound of the “T” in “Tallyho.” Will notify the Lure Operator, Timer and Handler of any issue with the release or the course that results in a rerun or a non-qualifying score. The Huntmaster shall stop the lure in the event of a safety issue with the course or the dog.

Lure Operator: The Lure Operator is responsible for communicating to the Trail Chair, any concerns regarding the track layout. They are responsible for operating the lure in a safe manner for all breeds. The Lure Operator will make a test run beforehand. The Lure Operator will receive communication from the Huntmaster regarding any special needs a particular dog may have (fast, slow, old, new, etc). The Lure Operator will do all they can to get the best time for your dog. The Lure Operator will not move the lure at the end until the dog is leashed and off the course. For the utmost safety, the Lure Operator will position themselves so that they have a view of the entire course and will watch the dog the entire way until the dog is leashed and off the course. The Lure Operator will stop the lure on a signal from the Huntmaster, but shall automatically stop the lure any time a dog becomes entangled in the string or when a potentially dangerous situation may develop

Queing Up After dogs have been roll called and put in a run order, we will line them up about 6 at a time. Anyone that does not have a catcher or a releaser in place and ready could be moved back in the order. Dogs not present for their Time Block will be added to the next available Time Block – with the exception of conflicts. Conflicts will be handled on a case-by-case basis at the field. We strive to keep the track running smoothly with as few delays as possible. For more information see the section on Time Blocks

SAFETY

Safety is the focus of the Speed Dog Crew. We work with the host club to ensure the safety of the course. We pride ourselves on the conduct of the crew to help maintain an atmosphere of helpfulness, fun and friendship, all while helping to ensure both human and dog are as safe as possible. We make sure regulations are followed to make the event not only safe, but fair. We run a test dog prior to the start of the event and each time we have to change Lure Operators. Prior to moving the lure to position for the start, the lure operator will announce “hold your dogs” to caution owners and the Huntmaster will caution handlers to be careful of the line.

FIELD CONDITIONS

FIELD

The Fast CAT Track will be fully fenced with mesh fencing and will have gates at the entrance and exit. The track is fairly flat and mowed short.

Electronic Timers will be used to record run times



Please bring your own shade and water.

The track is set up on a multi-purpose athletic field. Grass is short and the field is mostly flat and level

Only authorized personnel will be permitted near the lure operators tent.

For Fast CAT - Dogs are not permitted to run in choke collars (including limited slip martingales) , harnesses, E-Collars or prong collars.

You CAN bring your dogs to the line in a choke, limited slip or harness.

Restroom facilities are near the field

Please pick up after your dog!

GENERAL ENTRY INFORMATION

This event is open to all dogs at least one year of age by the day of the event. Dogs must be individually registered with the American Kennel Club, recorded in the FSS program, dogs with PAL numbers, and dogs enrolled in the AKC Canine Partners program. A dog may enter only one time per event. Each event has an individual event number. There are two events each day. Events are run **CONCURRENTLY** – meaning the option to run both events in the same time block is allowed.

Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form. Breed should be marked as “All American Dog.” All American dogs without an Canine Partner number **MAY** register for the AKC Canine Partner program at the field and run for qualifying points

Event Information

Field hours are 7:30 am until 5 pm each day EXCEPT SUNDAY. **The field will shut down at 3 pm on Sunday** In the event of weather or ground conditions the Event Committee may start the events earlier or later than posted. All entrants present during the posted times will be allowed to run as long as conditions are deemed safe.

Roll Call (Inspection) and Run Order

FOR THESE EVENTS WE WILL BE HOLDING A "ROLLING ROLL CALL"

Inspection begins 15 minutes before your scheduled Time Block. We inspect the dogs as they arrive at the field. You will receive a Run Ticket when you arrive at the field. Take your Run Ticket to the Roll Call area. Dogs must be checked in and inspected prior to **EACH** run. Inspection will check for general fitness and for females in season. Females in season and lame dogs are not permitted to run. Handicaps will be verified at inspection.

Once your dog has passed inspection, bring your Run Ticket to the Paddock Master Table. You will then be put in the run order. If you have a catcher or a releaser, make sure they are in the correct area at **LEAST** three dogs ahead. This really helps to keep things moving!

If you have a 2nd run in the same Time Block you must come back and pick up your Run 2 ticket, be re-inspected and be put on the run order list. If you have a 2nd run in another Time Block – please come back then.

Conditions of Entry – Read Carefully

NOTICE TO ALL EXHIBITORS

ALL DOGS RUN AT OWNERS SOLE RISK

All entries must be one year of age or older on the day of the test.

- Each dog requires an individual entry form for each event in which it is entered. Or enter online (EASIER!!)
- Entries will not be accepted without fees, signatures, and the “Agreement” found on the Official AKC Entry Form.
- Bitches in season and lame dogs will be refused entry and, if presented at inspection, will be refunded entry fees.
- Mixed breeds must be spayed or neutered to be eligible to run. AKC registered dogs with breed disqualifications may be entered.
- Coursing is an athletic activity that can tax a dog’s physical strength.
- Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog’s entry into a test, and in such instances, applicable entry fees will be refunded.
- Continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available.
- Exhibitors should follow their veterinarian’s recommendation to assure their dogs are free of parasites, any communicable diseases and have appropriate vaccinations.
- The Huntmaster is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve a testing dog.
- Any decisions made by the event’s officiating judge(s) regarding the performance of an entered dog shall be final. Full discretionary power is given to the Huntmaster to withhold any and all qualifications for lack of merit. The Huntmaster is responsible for ensuring compliance with the AKC Regulations on the field.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.
- Persons exhibiting conduct detrimental to AKC/any dog(s)/other person(s) will be asked to leave the trial site.
- The event-hosting club, its agents, members, representatives, volunteers, James River Kennel Club, Speed Dog Coursing, assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs, property and further assumes no responsibility for injury to children or spectators before, during, or after this event

- There will be portable restroom facilities located near the field. Bring your own shade. No littering.

- All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the club, or in persons to whom assignments of such rights have been made in writing by the club. NEW TIME BLOCK SIGN UP INFO

We will be using the “block schedule” running order. A link for YOU to pick your time block is provided at the end of the online entry form. If you do not sign up online, a link will be emailed to you when your entry is received.

Concurrent Run Scheduling

We run events CONCURRENTLY. This means you can schedule your runs in the same Time Block (if there is room), different Time Blocks both in the morning, both runs in the afternoon or a run in the morning and a run in the afternoon. The choice is yours., Anyone who does not have a Time Block prior to the event will be assigned one at the field.

Electronic sign-up

We are using SignUp Genius to schedule runs. A link for YOU to pick your time block is provided at the end of the online entry form. If you do not sign up online, a link will be emailed to you when your entry is received.

- 1) Make sure you only sign up for the days you entered and the number of runs per day that you entered!
- 2) There is ONE Sign Up Form divided by days and Time Blocks. You need to make sure you click on EACH day you entered and sign up for a time slot
- 3) We are limiting the number of people at the field at one time. Which will also reduce your wait time.
- 4) We are running CONCURRENT events. What this means is that you can run and then run again within the same time block (you would sign up for 2 runs per dog). This is assuming there is space in the Time Block for the 2nd runs. If space is not available, you will need to sign up for another time block for your 2nd run.
- 5) Make sure you go to the BOTTOM of the form when you are done and SUBMIT
- 6) Our wonderful volunteers will run first so that they can be there to help make sure we all have a good time and do it safely.
- 7) If you do not know what Time Block you want when you enter, you will receive an entry confirmation email. The email will include the Sign-Up link for you to access at a later date. PLEASE DO NOT SHARE THIS LINK
- 8) If you have any questions about getting your dog signed up - email us speeddogcoursing@gmail.com
- 9) When a block is full, runs cannot be added.
- 10) This information is for those of you who are PRE-entered and paid. This is NOT for Fun Runs or On-Site entries.
- 11) The Time Block Sign Up is ONLY for people that have entered and paid for runs. Those that Sign Up for Time Blocks without entering first, will have their Time Block Sign Ups deleted.
- 12) Pre-Entered dogs without a Time Block, On Site Entries and Fun Runs will all be assigned a Time Block at the field. Be aware that most of the time all the morning time blocks are filled before the events begin. In other words, do NOT expect to walk up and run!
