In general, follow the signs to Rt. 501 North. Here are the details:

US 460 - From the West of Lynchburg: From 460, take the right-hand exit to 460 E Business (Timberlake Rd). Proceed for about 3 miles to Route 501. Exit onto 501 North and go about 2 miles to a traffic light at Rt. 221

Continue straight on Rt. 501 N through the light at Rt. 221. At the next light, turn left to stay on Rt. 501 North. At the next light at Boonsboro Rd., turn left (still 501 N) and go about 2 miles. Turn left onto Coffee Road (Rt. 644) [Dollar General Store will be on the left] and go about 2 miles. The Boonsboro Ruritan Club Building is on the right.

US 460 - From the East of Lynchburg: Exit Rt. 460 at Candler's Mountain Rd (a right turn exit). Follow signs to Rt. 501 North (River Ridge Mall will be on your left, and La Quinta Inn will be on your right). Take the exit ramp to the right to Rt. 501 North. Follow 501 N for about 3 miles to Lakeside Dr./Rt. 221 See italics above.

US 29 - From the North of Lynchburg: After passing the town of Amherst, stay on Route 29 South. (Do not take Business Rt. 29 South). This is the limited-access Madison Heights Bypass. After crossing the James River, Rt. 29 will join Rt. 460 West. DO NOT take Rt. 501 North Business at Campbell Ave. Continue to Candler's Mountain Rd and follow signs for Rt. 501 North. (River Ridge Mall is on the left, and La Quinta Inn on the right). Take the exit ramp to the right to Rt. 501 North. Follow 501 N for about 3 miles to Lakeside Dr./Rt. 221. See italics above.

US 29 - From the South of Lynchburg: Follow Business Rt. 29 North into the city limits (pass River Ridge mall entrance on your right). Take the exit ramp to the right to Rt. 501 North and proceed for about 3 miles to Rt. 221. See italics above.

- 2) There are THREE (3) Tabs. One for each day. You need to make sure you click on EACH tab for the days you entered and sign up for a time slot
- 3) We are limiting the number of people at the field at one time. I will be sending the "Safe Protocols" via email after entries close.
- 4) We are running CONCURRENT events. What this means is that you can run, rest your dog and then run again within the same time block (you would sign up for 2 runs per dog)

- **NOTICE TO DOG OWNERS/EXHIBITORS**

WHEN YOU SIGN THE ENTRY FORM, YOU AUTOMATICALLY AGREE TO THE FOLLOWING TERMS CONCERNING MOTELS EXTENDING THEIR PLACE TO YOU. THE FOLLOWING RULES HAVE BEEN ESTABLISHED FOR THE GOOD OF ALL EXHIBITORS CONCERNED.

- All exhibitors read the regulations on hotel/motel accommodations.
- All motels accepting dogs require plastic under crates
Plastic sheeting is to be placed under every crate in motel rooms. This will keep carpets clean & dry. It will be the responsibility of each exhibitor to provide his/her own plastic sheeting for each crate.
- Dogs must be crated when owner is out of the room. **NO EXCEPTIONS!**
- Dogs must be kept on a leash at all times while in the hotel, lobbies or on hotel grounds. Rooms & lobby must be kept clean of dog debris.
- Dogs should be “exercised” in designated areas on motel premises. Every dog owner/handler is expected to pick up after his/her dog & dispose of waste in

designated trash cans. It is the responsibility of the dog owner to find out from the innkeeper where these areas & cans are located.

- Due to severe clogging problems with the drain pipes, no dog may be bathed in the hotel. Crating & bathing facilities with hot & cold water are available at the show site.
- Rooms will be inspected daily by members of the hotel staff & observed violations or damages will be reported to the hotel management and/or the investigative committee.
- The investigative committee, working with a fair & equitable system, is charged with investigating complaints.
- Each dog owner/registrant is expected to cooperate with the investigative committee, hopefully settling damage claims on the spot, or else must be willing to furnish information such as insurance policy numbers & other pertinent information as required/requested.

A helper (if you have one) to catch/release your dog. If not, we can help. Or, if your dog has a REALLY reliable recall, you may recall your dog back to you.

FAST CAT

The FAST CAT is a timed straight race of 100 yards where a dog chases a lure. Dogs are run singularly and earn points based on their handicapped speed. There are no placements. Titles are issued at designated benchmarks. The dog's time to complete the 100 yard dash is converted into MPH. Dogs earn points based on their handicapped speed. A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:

- 18" or greater = handicap is 1.0
- 12" up to less than 18" = handicap is 1.5
- Below 12" = handicap is 2.0

$204.545 / \text{time} = \text{MPH}$

Example: The dog's time is 8.14 seconds.

$204.545 / 8.14 = 25.13 \text{ MPH}$

Points = MPH multiplied by the dog's handicap

Titles are earned by accumulating points. The following titles will be awarded:

BCAT = 150 points

DCAT = 500 points

FCAT = 1,000 points

FCAT# = every additional 500 points.

Top 20 by Breed by Year: The AKC Fast CAT website will feature the Top 20 Fastest Dogs by Breed by Year national standings. The standings will be updated as event results are processed.

Fast CAT is open to all dogs 12 months of age or older that are individually registered/ listed with the AKC registration as purebreds, Foundation Stock Service (FSS) dogs, Purebred Alternative Listing (PAL) dogs and AKC Canine Partner Program.

Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded.

Entries will be acknowledged by E-MAIL IF **legible e-mail** address is provided.

ALL DOGS RUN AT OWNER'S SOLE RISK

- All entries must be 12 months of age or older on the day of the test.
- Each dog requires an individual entry form.
- Entries will not be accepted without fees, signatures, or the "Agreement" found on the Official AKC Entry Form.
- Bitches in season and lame dogs will be excused. Entries will be refunded
- Mixed breeds must be spayed or neutered to be eligible to run. AKC registered dogs with breed disqualifications may be entered.
- Coursing is an athletic activity that can tax a dog's physical strength.
- Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog's entry into

a test, and in such instances, applicable entry fees will be refunded

- **A \$5.00 fine will be assessed for any loose dog on the field that is not competing in the course in progress.**

Battery powered, continuous loop equipment will be used. Lures consist of white plastic.

Light Curtain times will be used. Stop watches will be available as back up timers

- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of parasites, any communicable diseases and have appropriate vaccinations.
- The Huntmaster is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve a testing dog.
- Persons exhibit conduct detrimental to the AKC/any dog(s)/other person(s) will be asked to leave the trial site.
- Bring your own shade and water.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.

TIPS FOR HANDLERS

- The field is fenced. However, it is strongly recommended that prior to running your dog, you have good "recall" control over your dog, as the dogs will be off leash.
- Handlers should wear comfortable shoes and be physically able to hold and release their dogs, as well as catch them.
- Dogs will be brought to the start line on leash and released only upon a verbal signal ("Tally-Ho!") from the Huntmaster. Dogs may be released by hand, folded leash or using a traditional lure coursing slip lead.
- **Handler should have someone familiar with the dog at the end of the course to retrieve the dog or have someone else release their dog at the start line. The handler is expected to promptly secure the dog and leave the field with the dog on leash.**

Handlers are allowed to recall their dogs

- Lure coursing is a physically demanding sport so please make sure your dog is in good shape. If you are not sure, make an appointment with a veterinarian to get an opinion.
- Handlers are advised to warm up their dogs prior to their run and walk them for about 10 minutes afterwards.
- Any person, upon reasonable complaint, may be asked to leave the grounds of the test by the Field Committee and may be disciplined by the AKC. Children must be under control of their parents or guardian(s) at all times.
