EQUIPMENT and CREW

Lure Equipment: Speed Dog runs all their Fast CATs utilizing a continuous loop system. Speed Dog uses and endorses the SwiftPaws system for their record in safety and reliability. The lure or "bunny" consist of white plastic bags. Additionally, a squawker is sometimes used – if track conditions allow. The lure is attached to string that is set in a continuous loop and the string is pulled/pushed by an electric motor (SwiftPaws),

Timing Devices: Speed Dog uses and endorses Farm Tek electronic timing devices. At most events we have a redundancy system set up to help reduce timing issues and reruns.

Field Conditions. The field is fairly level. The surface is grass that is mowed short. The track is approximately 460' long and is fully fenced with mesh fencing. Mounted entry and exit gates are also part of the track. Handlers may walk the course to the catch area **BEFORE** their dog is released.

Hunt Master Is not just someone standing at the Start line twirling their arm, they are an integral part of the overall safety of the dog and human. They are in complete charge of all hounds and handlers on the field. They are responsible for calling the next dog/handler onto the course. They are responsible for making sure the correct dog is on the start line. They are responsible for checking collars. The Huntmaster explains the release and, if necessary, the retrieval before the dog is released. They are responsible for making sure the lure is in position and traveling in the correct direction before calling the dog/handler onto the course. The handler should communicate to the Huntmaster any special needs the dog may have (Fast, slow, old, new). The Huntmaster will communicate any needs to the Lure Operator. The Huntmaster shall question the Lure Operator, Timer and handlers asking "Are you ready?" After affirmative answers from all parties, the Huntmaster will begin the course. Provides a hand signal to the Lure Operator to start the lure. Gives the verbal signal "Tallyho" to release the dog from a standing start. The dog should not be slipped before the sound of the "T" in "Tallyho." Will notify the Lure Operator, Timer and Handler of any issue with the release or the course that results in a rerun or a non-qualifying score. The Huntmaster shall stop the lure in the event of a safety issue with the course or the dog.

Lure Operator: The Lure Operator is responsible for communicating to the Trail Chair, any concerns regarding the track layout. They are responsible for operating the lure in a safe manner for all breeds. The Lure Operator will make a test run beforehand. The Lure Operator will receive communication from the Huntmaster regarding any special needs a particular dog may have (fast, slow, old, new, etc). The Lure Operator will do all they can to get the best time for your dog. The Lure Operator will not move the lure at the end until the dog is leashed and off the course. For the utmost safety, the Lure Operator will position themselves so that they have a view of the entire course and will watch the dog the entire way until the dog is leashed and off the course. The Lure Operator will stop the lure on a signal from the Huntmaster, but shall automatically stop the lure any time a dog becomes entangled in the string or when a potentially dangerous situation may develop

Queing Up After dogs have been roll called and put in a run order, we will line them up about 6 at a time. Anyone that does not have a catcher or a releaser in place and ready could be moved back in the order. Dogs not present for their Time Block will be added to the next available Time Block – with the exception of conflicts. Conflicts will be handled on a case-bycase basis at the field. We strive to keep the track running smoothly with as few delays as possible. For more information see the section on Time Blocks

SAFETY

Safety is the focus of the Speed Dog Crew. We work with the host club to ensure the safety of the course. We pride ourselves on the conduct of the crew to help maintain an atmosphere of helpfulness, fun and friendship, all while helping to ensure both human and dog are as safe as possible. We make sure regulations are followed to make the event not only safe, but fair. We run a test dog prior to the start of the event and each time we have to change Lure Operators. Prior to moving the lure to position for the start, the lure operator will announce "hold your dogs" to caution owners and the Huntmaster will caution handlers to be careful of the line.

FIELD CONDITIONS

FIELD

The Fast CAT Track will be fully fenced with mesh fencing and will have gates at the entrance and exit.

Electronic Timers will be used to record run times



Please bring your own shade and water.

Parking is very close to the field.

Only authorized personnel will be permitted near the lure operators tent.

For Fast CAT - Dogs are not permitted to run in choke collars (including limited slip martingales), harnesses, E-Collars or prong collars.

GENERAL ENTRY INFORMATION

This event is open to all dogs at least one year of age by the day of the event. Dogs must be individually registered with the American Kennel Club, recorded in the FSS program, dogs with PAL numbers, and dogs enrolled in the AKC Canine Partners program. A dog may enter only one time per event. Each event has an individual event number. There are two events each day. Events are run **CONCURRENTY** – meaning the option to run both events in the same time block is allowed.

Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form. Breed should be marked as "All American Dog." All American dogs without an Canine Partner number **MAY** register for the AKC Canine Partner program at the field and run for qualifying points



Event Information

Field hours are :730 am until 5 pm Friday and Saturday and 7:30 until 3 pm on Sunday. In the event of weather or ground conditions the Event Committee may start the events earlier or later than posted. All entrants present during the posted times will be allowed to run as long as conditions are deemed safe.

**Day of trial entry OPENS at 10 am and CLOSESy at 3 pm or whenever time slots are filled (whichever comes first).

Roll Call (Inspection) and Run Order

FOR THESE EVENTS WE WILL BE HOLDING A "ROLLING ROLL CALL"

Inspection begins 15 minutes before your scheduled Time Block. We inspect the dogs as they arrive at the field. You will receive a Run Ticket when you arrive at the field. Take your Run Ticket to the Roll Call area. Dogs must be checked in and inspected prior to **EACH** run. Inspection will check for general fitness and for females in season. Females in season and lame dogs are not permitted to run. Handicaps will be verified at inspection.

Once your dog has passed inspection, bring your Run Ticket to the Paddock Master Table. You will then be put in the run order. If you have a catcher or a releaser, make sure they are in the correct area at LEAST three dogs ahead. This really helps to keep things moving!

If you have a 2nd run in the same Time Block you must come back and pick up your Run 2 ticket, be re-inspected and be put on the run order list. If you have a 2nd run in another Time Block – please come back then.

We will do our best to work around conflicts.

Time Blocks

We will be using the "block schedule" running order. A link for YOU to pick your time block will be emailed to you shortly after closing.

Concurrent Run Scheduling

We run events CONCURRENTLY. This means you can schedule your runs in the same Time Block (if there is room), different Time Blocks but in the morning, both runs in the afternoon or a run in the morning and a run in the afternoon. The choice is yours., **Anyone who does not have a Time Block** prior to the event will be assigned one at the field...

Electronic sign-up

We are using SignUp Genius to schedule runs. A link will be emailed to you AFTER entries close.

- 1) Make sure you only sign up for the number of runs per day that you entered!
- 2) There are FOUR (4) Tabs. One for each day. You need to make sure you click on EACH tab for the days you entered and sign up for a time slot 3) We are limiting the number of people at the field at one time.
- 4) We are running CONCURRENT events. What this means is that you can run, rest your dog and then run again within the same time block (you would sign up for 2 runs per dog)
- 5) Make sure you go to the BOTTOM of each days page when you are done and SUBMIT
- 6) There are some time slots already filled those would be the wonderful volunteers that are there to help make sure we all have a good time and do it safely.
- 7) If you have any questions about getting your dog signed up email us speeddogcoursing@gmail.com
- 8) When a block is full, runs cannot be added.
- 9)This is for those of you who PRE-entered and paid. This is not for Fun Runs or those people that are doing day of entries.
- 10) Pre-Entered dogs without a Time Block, On site entries and Fun Runs will all be assigned a Time Block at the field

Conditions of Entry - Read Carefully

NOTICE TO ALL EXHIBITORS

ALL DOGS RUN AT OWNERS SOLE RISK

All entries must be one year of age or older on the day of the test.

- Each dog requires an individual entry form for each event in which it is entered. Or enter online (EASIER!!)
- Entries will not be accepted without fees, signatures, and the "Agreement" found on the Official AKC Entry Form.
- Bitches in season and lame dogs will be refused entry and, if presented at inspection, will be refunded entry fees.
- Mixed breeds must be spayed or neutered to be eligible to run. AKC registered dogs with breed disqualifications may be entered.
- Coursing is an athletic activity that can tax a dog's physical strength.
- Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded.
- Continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of parasites, any communicable diseases and have appropriate vaccinations.
- The Huntmaster is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve a testing dog.
- Any decisions made by the event's officiating judge(s) regarding the performance of an entered dog shall be final. Full discretionary power is given to the judge(s) to withhold any and all qualifications for lack of merit. The Judge(s) is responsible for ensuring compliance with the AKC Regulations on the field.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.
- Persons exhibiting conduct detrimental to AKC/any dog(s)/other person(s) will be asked to leave the trial site.
- The event-hosting club, its agents, members, representatives, volunteers, North Georgia Kennel Club, Speed Dog Coursing, assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event

- There will be portable restroom facilities located near the field. Bring your own shade. No littering.
- All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the club, or in persons to whom assignments of such rights have been made in writing by the club. All persons and animals attending these shows grant the club the right to use their likeness and voice in any matter without further consent.

Course and Equipment

- Safety: Safety is of utmost importance. It is the responsibility of the Event Committee to ensure the safety of the course, equipment and conduct of those involved with the event. A test dog will run prior to the start of the event to ensure that the equipment functions properly and volunteers understand their jobs. Prior to moving the lure to position for the start, the lure operator will announce "hold your dogs" to caution owners.
- 2) The Finish: The club will provide enough room for a safe run-out area. SDC will attempt to use a minimum of 50 yards. It is recommended an owner or someone familiar with the dog be at the finish to catch the dog once the test is completed. SDC will attempt to help at the end of the course to collect the dogs if the owner requests it.
- 3) **Timing Devices**: SDC will use electronic timers. The time to complete the 100 yard dash is recorded to the nearest 1/100th of a second. The time starts when any part of the dog breaks the electronic beam at the start line. The time stops when any part of the dog crosses the finish line. Stop watches will be used as a backup if the electronic timers don't function. In the event of manual timing, a starter's flag will signal the start when the dog's nose crosses the starting line and the time will be recorded by two timekeepers, each operating individually, at the finish line. The time will be the mathematical average of the two manually recorded times.
- 4) Lure Equipment: SDC uses a continuous loop system. The lure will be a white plastic bag or squawker. The lure will be propelled by an electric motor attached to a continuous loop set-up. Safety is the number one consideration in running this event.

- 5) Field Conditions. The field is reasonably flat, level and mowed short. The actual running area is approximately 150 yards long x 6 yards wide, with a plastic barrier. The release line is ten feet behind the start line. The course is 100 yards long with finish line timers (electronic or manual) and a 50-yard run-out area. Handlers may not walk the course with their dogs during the actual test, but they may walk the course to the catch area BEFORE their dog is released.
- The Hunt Master has control of the course. The Hunt Master oversees all dogs and handlers on the field, shall ensure handlers understand safe release and retrieval procedures, shall ensure the lure is properly positioned, shall ensure the Lure Operator, timers and starting line signal person are ready, shall signal the Lure Operator to start the lure and shall give the verbal signal "tallyho" to release the dog.
- 7) At the line: Exhibitors will be able to sign up for their run block before the event. Anyone who does not sign up for a run block will be randomly assigned into open slots available. Each exhibitor will receive a running order via e-mail prior to the event. Dogs will be lined up in the paddock area, with no more than five in line at a time. If you are in line, please ensure your catcher is at the finish area. Anyone who does not have a catcher ready will be moved back in line. Dogs that are not present during their run block will be moved to the next block and the next available dog will be inserted into the running order. The missing dog will be inserted into the running order as convenient when they arrive. If you miss your run time, you will not be required to wait until all dogs have run. You can run, within reason, when you arrive. OUR GOAL IS TO FOLLOW THE RUN ORDER, BUT ALSO TO KEEP THE COURSE RUNNING.
- 8) Operation of the Lure: The Lure Operator's job is to 1) ensure a safe run by operating the lure correctly, and 2) to get the best score for your dog. If your dog is new to the sport, tell the Hunt Master! That may mean operating the lure differently, to get his/her attention, as opposed to an experienced dog that needs little to no encouragement. If your dog is particularly fast for it's breed, simply advise the Hunt Master about your "fast dog." They will tell the Lure Operator, who will adjust the running of the lure to accommodate this. Th Lure Operator has experience and knowledge related to running various breeds, but every dog is different. We want you to have a good score.
- 9) Schedule and Event Hours: 8am until all scheduled runs are completed. In the event of inclement or other conditions or to assist with timely completion of the event, Event Committee may elect to start the events earlier or later than posted. In any event, all entrants present during the posted times will be allowed to run, if conditions are safe.
